### TRINITY PROJECT AWARDS PROGRAM

The SWR Institute is proud to offer its members the opportunity to present their projects through the Trinity Project Awards Program. This program provides an excellent venue to not only showcase our member companies but also their very unique project accomplishments as well.

"Trinity" was chosen as the name of this awards program because it defines the key submittal component. That is, we have three projects types (Sealant/Waterproofing/Restoration) and three member classifications (Contractor/Manufacturer/Associate). What sets this program apart from other awards programs is the collaborative partnership requirement. All submitted projects must have been a collaborative effort between an SWR Institute contractor, manufacturer and associate member. We feel this combination represents the 'best in class' for our industry.

All entries that meet the stated criteria will then be judged by a three person panel of SWR Institute peers. (Members of the panel will include a contractor, manufacturer and an associate member). Awards will be presented annually at the SWR Institute's Winter Technical Meeting.

The Trinity Project Awards Program is designed to be a very prestigious honor. It provides for recognition by fellow industry professionals but it also comes with considerable additional benefits. There is the award itself that the winning companies will get to display with pride in their home offices. And, there is the opportunity to have an article in the *Applicator* and a in-person presentation at a SWR Institute meeting that will highlight the project plus press releases to the industry announcing the winners.

Overall, the Trinity Project Awards Program offers considerable recognition to SWR Institute members. It allows the opportunity to receive public validation on work well done in a very challenging industry. We feel this program is a tremendous way for the Institute to thank the best people in the industry for the best work done!

We encourage everyone to partner with fellow SWR Institute members to submit your projects to the Trinity Project Awards Program. The efforts could result in winning this elite award and provide your company well deserved national recognition.

## Terms and Conditions

The Sealant, Waterproofing & Restoration Institute (SWR Institute) has created the Trinity Project Awards Program to recognize those projects that utilize SWR Institute resources and relationships.

### The terms and conditions of the Program are as follows:

- 1. Judging Criteria:** Entries will be judged based upon such items as complexity, technology/innovation, sustainment, safety, community/environmental impact, challenges/solutions and quality control to name a few. The panel will be comprised of three judges consisting of one contractor, one manufacturer and one associate member as established by the Awards Committee Chairman. Three year terms shall be employed to ensure continuity of judges. In order to establish rotating terms, initially the manufacturer shall possess a three year term; the contractor will have a two year term; and the associate will have a one year term. In the event of a conflict whereby a judge is associated with a submitted project, then the judge shall abstain from voting and an alternate judge will take his/her place for that year.
- 2. Categories:** In standing with the mission and purpose of SWR Institute, awards will be issued for (S)ealant, (W)aterproofing and (R)estoration type projects. Projects can either be new construction and/or remedial repairs. Projects can be submitted by any member and are not limited to the number of projects or classes that you can submit. In the event of multiple categorical submittals, there will only be one winner per year. On projects involving diversified work tasks, submitter shall declare only one entry classification per project.
- 3. Eligibility:** The Program is specifically promoting the use of SWR Institute resources and relationships. As such, only those projects involving a collaborative team approach using all of the member classes: contractor, manufacturer and associate member. Projects must be at least one year old from the date of completion of the project but not over 5 years old from the date of submission. Only those projects involving active members shall be eligible whose membership must begin no later than the commencement of the construction of the project.
- 4. Deadline:** The deadline for submission is on or before December 31<sup>st</sup> of any year to be considered for the Program for that year. SWR Institute's administrative office in Kansas City, Missouri shall date stamp each project submitted on or before December 31<sup>st</sup> of any given year. Any project received after December 31<sup>st</sup> will be considered submitted to the Program for the next year.
- 5. Recognition:** Winning projects will be announced at SWR Institute's Winter Technical Meeting. Each categorical winner and project team (i) will receive the **"SWR Trinity Project Award"** plaque at the Winter Technical Meeting; (ii) have the opportunity to submit the project as an article in the *Applicator* magazine; (iii) have the opportunity to present the project at the following SWR Institute Fall Technical Meeting; (iv) be a part of an industry press announcement concerning the Award; and (v) be recognized on SWR Institute's website and in SWR Institute's *Member Briefs*.
- 6. Release:** The submitter shall agree to all terms and conditions of this project awards program and as such permits SWR Institute to use the project in any promotional activities (i.e. advertising, articles, photos, awards, etc.). The submitter shall obtain the execution of the Authorization Form from all necessary companies to the project submitted including, but not limited to the owner of the property where the project is located, the general contractor (if any), the developer (if any), the contractor, manufacturers and associates.
- 7. Use of Award:** If the submitter is selected as the recipient of the SWR Trinity Project Award from SWR Institute, the submitter and all parties executing the Authorization Form agree to display the SWR Trinity Project Award consistent with the terms of the Program. Any misinformation submitted on the application may result in SWR Institute withdrawing said award.

**8. No Transfer of Award:** Only the companies executing the Authorization Form shall be allowed to represent that it has received the SWR Trinity Project Award as described herein.

**9. Amendments or Modifications to the Program:** SWR Institute reserves the right, in its sole discretion, to change the terms and conditions governing the Program from time to time.

**10. Hold Harmless and Indemnity:** The submitter and all of the companies executing the Authorization Form shall hold SWR Institute, its officers, directors, guests, employees, agents, and any other entity acting for or on its behalf (hereafter referred to collectively as its "Affiliated Persons") free and harmless and agrees to indemnify SWR Institute and its Affiliated Persons from any claim, loss, cost, liability, damage or cause of action that may occur whatsoever (including all costs, expenses, legal fees and expert fees) from or in any way related to the use or designation has having received the SWR Institute Trinity Project Award or the participation in any manner with respect to this Program. The submitter and all of the companies executing the Authorization Form further hold SWR Institute and its Affiliated Persons free and harmless and agrees to indemnify SWR Institute and its Affiliated Persons from any claim, loss, cost, liability, damage or cause of action that may occur whatsoever (including all costs, expenses, legal fees and expert fees) from any third party concerning Company's participation in this Program.

**11. Miscellaneous:** The provisions, covenants and conditions of the Program shall bind and inure to the benefit of the legal representatives, heirs, successors and assigns of each of the parties executing the Authorization Form, except that no assignment by said parties shall be allowed and that no attempted assignment by said parties shall vest any right in the assignee of said parties. Any waiver by SWR Institute of any breach or breaches, default or defaults of said parties hereunder, shall not be deemed or construed to be a continuing waiver of such breach or default nor as a waiver of or permission expressed or implied, for any subsequent breach or default. This Program, the Application and any documents submitted thereto contain the entire agreement between the parties and except as specifically provided herein, no modification of this Program shall be binding upon the parties unless evidenced by an agreement in writing signed by the parties hereto after the date hereof. The Program shall be construed and interpreted according to the laws of the State of Missouri, notwithstanding the operation of any conflict or choice of law statutes or decisional law to the contrary. Exclusive jurisdiction and venue shall be in the Federal or State Courts in Jackson County, Missouri.

**12. Disclaimer:** SWR Institute and its Affiliated Persons cannot accept responsibility for the accuracy of the information and representations submitted pursuant to this Program and as a result SWR Institute and its Affiliated Persons disclaim any liability with respect to the submissions and/or award made pursuant to this Program.
